1. Japan

(1) Big home appliances : Recycling fee is paid by consumer, when the disposed big home appliances. The recycling fee is collected through retailer, and trasered to manufacturer. Manufacturer has responsibility to recycle discarded big home appliances.

(2) Packaging and container : Manufacturer of packaging and container and manufacturer using package atn container have responsibility to recycle. Most of manufacturer pay recycling fee to disgnated organization.

(3) Automobile recycling : Consumer should pay recycling fee in advance. The recycling fee is managed by association of manufacturer and distributed to proper treatment of specific items, which CFCs, air bags and automobile shredder dust.

2. India for e-waste (ongoing), and Vietnam for e-waste, automobile, rublicant, battery and others(preparation stage)

They only emphasis physical responsibility. Financial scheme is not defined in the regulation. Manufacturers bear the cost to satisfy the physical responsibility.

3. China onr e-waste

Chinised government collect recycling fee from manufacturers. Government distribute the fund to recycling companies.
