Decision making process:

A. Main steps:

1. Acknowledgement of receipt of equipment by Mega Store to correspondent
2. Declaration to Customs and identification of the equipment in presence of the customs officers on basis of Bill of loading, invoice , transportation bill , conformity document , or use of a custom agent with which Maga store should sign a contract of services (custom fees, Maga Store to handle the documents mentioned to the custom officer)
3. Collection of the material and transportation to Mega store warehouse
4. Separation and Testing to determine if the material can be reused, refurbished (dismantling) , parts that can be used or not
5. Storage of materials according to their final use
6. Precede to reparation or refurbishment

In all these processes, respect all measures for safety of workers, public and environment in general

B. Challenges



1. Lack of financial and technical capacities
2. Lack of appropriate infrastructures
3. Absence of legislation related to e-waste
4. Weak of good governance (Networking, coordination, , cooperation-regional approach--)
5. Absence of awareness raising and sensitization programs of the public, officials and decision makers
6. Health and environmental risks, particularly inhalation of toxic material
