Dear Carla,

I am writing to you with regard to the kind invitation to submit inputs on the first revised drafts of the general and pesticides technical guidelines.

In that sense, please find attached the comments provided by the Ministry of Environment and Sustainable Development.

We understand that the deadline has expired, however we would really appreciate if you could take it into account.

I really appreciate if you could acknowledge receipt of this information.

- Technical guidelines on the environmentally sound management of wastes consisting of, containing or contaminated with the pesticides aldrin, alpha hexachlorocyclohexane, beta hexachlorocyclohexane, chlordane, chlordcone, dieldrin, endrin, heptachlor, hexachlorobenzene, hexachlorobutadiene, lindane, mirex, pentachlorobenzene, pentachlorophenol and its salts, perfluorooctane sulfonic acid, technical endosulfan and its related isomers or toxaphene or with hexachlorobenzene as an industrial chemical":
 - At the bullet I.B. the guideline describes its scope about pesticides in order to relate directly the residues which are under control of the Basel Convention. It will be useful to propose or relate the different residue categories described in bullet II.A. for each pesticide that is treated by the guideline.
 - At the bullet IV.G.4. of the guideline, which is related to the low-content-pesticides residues elimination methods, indicates that for more information, see subsection IV.G.4 of the general technical guidelines. Nonetheless, the General Technical Guidelines, at that bullet, does not provide a particular method. Instead, the guidelines recommend to refer to the Environmentally Sound Management Guidelines. Therefore, for pragmatically matters, it would be convenient that this guideline refers directly to the last document mentioned.
- We have no observations about General technical guidelines on the environmentally sound management of wastes consisting of, containing or contaminated with persistent organic pollutants.

Estimado Juan Sebastian,

En respuesta a la solicitud de la Secretaría del Convenio de Basilea en referencia, atentamente le remito los siguientes comentarios transmitidos por la ANLA.

- Sobre las “*Technical guidelines on the environmentally sound management of wastes consisting of, containing or contaminated with the pesticides aldrin, alpha hexachlorocyclohexane, beta hexachlorocyclohexane, chlordane, chlordanone, dieldrin, endrin, heptachlor, hexachlorobenzene, hexachlorobutadiene, lindane, mirex, pentachlorobenzene, pentachlorophenol and its salts, perfluorooctane sulfonic acid, technical endosulfan and its related isomers or toxaphene or with hexachlorobenzene as an industrial chemical*”:
 - a) En el numeral I.B. de la Guía se realiza la descripción de los pesticidas que se encuentran dentro del alcance de la misma, para efectos de asociar de manera directa los residuos que son objeto de control de acuerdo con las disposiciones del Convenio de Basilea, resulta de utilidad proponer o asociar las posibles categorías de clasificación de los residuos descritas en el numeral II. A., para cada uno de los pesticidas que son objeto de la guía.
 - b) En el numeral IV.G.4 de la Guía, relacionado con los métodos de eliminación de pesticidas “low content” se remite al numeral IV.G.4 de la Guía General; no obstante en este último numeral no se hace referencia a ningún método en particular sino que a su vez se recomienda consultar las Guías técnicas para el manejo ambientalmente racional de desechos (ESM). En consecuencia y para efectos prácticos, se estima conveniente hacer referencia de manera directa al último documento mencionado.
- Con relación a la Guía “*General technical guidelines on the environmentally sound management of wastes consisting of, containing or contaminated with persistent organic pollutants*” no se tienen observaciones.
