DEVELOPMENT OF FACT SHEETS ON THE ENVIRONMENTALLY SOUND MANAGEMENT OF PRIORITY WASTE STREAMS

CONSULTANCY ANNOUNCEMENT AND CALL FOR APPLICATIONS BY 7 APRIL 2014

The Secretariat of the Basel Convention refers to decision BC-11/1 on Follow-up to the Indonesian-Swiss country-led initiative to improve the effectiveness of the Basel Convention whereby the eleventh meeting of the Conference of the Parties mandated an expert working group to further elaborate and implement actions on initial short-term work items and to develop a work programme for additional priorities and key work items and actions for the implementation of environmentally sound management (ESM).

The expert working group met in December 2013 and decided on several short-term activities to implement ESM. Recalling that COP 11 had requested the expert working group to identify ESM elements and to develop practical guidance on certain waste streams, the group agreed to develop fact sheets on the ESM of priority waste streams. The group requested the Secretariat to retain a consultant for this purpose.

Terms of Reference Consultant to develop fact sheets on environmentally sound management of priority waste streams

Background

By decision BC-11/1, the eleventh meeting of the Conference of the Parties to the Basel Convention adopted the Framework for the environmentally sound management (ESM) of hazardous wastes and other wastes¹ which establishes a common understanding of what ESM encompasses; identifies tools to support and promote the implementation of ESM; and identifies strategies to implement ESM. By the same decision, an expert working group was mandated to further elaborate and implement actions on initial short-term work items and to develop a work programme for additional priorities and key work items and actions for the implementation of ESM.

The expert working group met in December 2013² and decided on several short-term activities to implement ESM. Recalling that COP 11 had requested the expert working group to identify ESM elements and to develop practical guidance on certain waste streams³, the group agreed to develop fact sheets on the ESM of priority waste streams. In support of this work, which it was anticipated would be assigned to a consultant during the intersessional period, the expert working group agreed on a list of priority waste streams (see Annex 1) and developed a template for fact sheets to be completed for each of the identified priority waste streams (see Annex 2).

Activity

A consultant shall be retained to:

- (i) Develop a draft fact sheet on the basis of the template in Annex 2 of this document for each of the priority waste streams identified by the expert working group and listed in Annex 1 (i.e. 8 fact sheets of approximately 4-5 pages each);
- (ii) Submit the draft fact sheets to the Secretariat for submission to the expert working group on ESM;
- (iii) Finalise the draft fact sheets on the basis of the feedback received from the expert working group.

The consultant shall undertake these activities in accordance with the timeframe indicated below and as may be further indicated by the Secretariat.

Qualifications

The consultant must have at least 5 years work experience in the field of hazardous waste management, preferably with experience in issues directly related to the Basel Convention. The consultant must have excellent English reading and writing skills, and the ability to compile and synthesise large quantities of information into a practical, brief, user-friendly document.

Timeframe

The contract will require approximately **21 days of work**. A <u>first draft</u> of the fact sheets would need to be developed by 7 May 2014, in time for the expert working group's second meeting scheduled from 29 to 31 May 2014. A <u>final draft</u> of the fact sheets would be developed thereafter, on the basis of the feedback received from the expert working group and within the timeframe that may be agreed by the group. The contract will commence as soon as the appropriate candidate is identified and selected.

 - d. Classification under BC (annexes)

2. Waste management

- a. Packaging and labelling

 Depends on form of tyres (whole or fragmented): carried in bulk or big bags
- b. Collection

 Take-back systems are recommended
- c. Transportation

 Examine existing national and international transportation regulation, required transportation documentation
- d. Storage

 Recommended that interim storage longer than [time] should be licensed
- 3. Disposal operations (annexes IV A and IV B)
 - a. BAT / BEP and BREF

 As described in the BC guidelines and other guidelines/instruments
- 4. Sustainable materials management
 - a. EPR systems

 Examples in countries
 - b. Financing systems

c. Incentives and disincentives

5. Legislation

Information about available treatment and subsequent disposal capacities (reuse – retreading – recycling – energy recovery) in countries and regions to apply ESM

Mandatory licensing recommended for recovery and final disposal operations

Inspection, monitoring, reporting

National, regional and international examples (e.g. EMAS standards)

10. TBM

Information on national and regional trade rules (e.g. import bans) and conditions for trade
