



# **Emergency mechanism**

## What is the emergency mechanism?

In cases of emergency resulting from incidents arising from transboundary movements of hazardous wastes and other wastes and their disposal, developing countries or countries with economies in transition can apply for assistance from the Technical Cooperation Trust Fund of the Basel Convention.

The Conference of the Parties by decision V/32 decided to enlarge the scope of the Technical Cooperation Trust Fund. This emergency mechanism allows the Secretariat of the Basel Convention, upon request, to use the funds allocated to the Technical Cooperation Trust Fund:

- To assist a Party which is a developing country or a country with economy in transition in case of an incident occurring during a transboundary movement of hazardous wastes or other wastes covered by the Basel Convention in order:
  - To estimate the magnitude of damage occurred or damage that may occur and the measures needed to prevent damage;
  - To take appropriate emergency measures to prevent or mitigate the damage;
  - To help find those Parties and other entities in a position to give the assistance needed;
- □ To assist a developing country Party or Party with economy in transition in developing its capacity-building and transfer of technology and in putting in place measures to prevent accidents and damage to the environment caused by the transboundary movement of hazardous wastes and other wastes and their disposal.

## What to do in case of an incident

In case of an incident, developing country parties and parties with economies in transition wishing to apply for emergency assistance need to complete and submit to the Secretariat the Standard form [http://www.basel.int/EmergencyFund/standardform] which is available in all six official United Nations languages on the website of the Basel Convention.
