Background

Come and learn more about the new proposal for adding new e-waste types in the scope of the Follow-up Partnership to the Partnership for Action on Computing Equipment, its projects and the debate on what could be future of its work.

During the side event, there will be a brief presentation of the work undertaken by the partnership working group, including the proposal for a new name for the partnership and a debate on new challenges related to the growing digitalization accelerated by the COVID19 pandemic. The participants will be invited to participate in a debate on new and existing e-waste issues in their national and regional context.

According to the Global E-waste Monitor report (2020), in 2019, 53.6 million metric tons of e-waste were generated in the world. Only 17.4 % was documented as formally collected. It is predicted that e-waste generation, in the coming years, will boost, especially in low and mid-level income countries.

The Parties to the Basel Convention at the fourteenth Conference of the Parties, in 2019, established a Partnership to follow-up on the activities of the Partnership for Action on Computing Equipment, which had concluded its work, in 2017 (Decision BC-14/19 Part I).

The aim of this Partnership is to continue to raise awareness and keep the necessary attention to the challenges posed by the growing amount of e-waste generated in the world, especially in developing countries and countries in economic transition.
